

## Future work programme

### 1 Introduction

- 1.1 This report suggests, for discussion, principles for the future work of the Group and a draft work programme for 2011/12.

### 2 Background

- 2.1 The role of the Chief Officers' Group - North Yorkshire and York (the Group) is to provide leadership and coordination across sub-regional partnership structures and public services generally and to advise Local Government North Yorkshire and York.
- 2.2 The refreshed Sustainable Community Strategy 2011/14 will focus on the issues which are most critical to partners over the next few years and which can only be tackled effectively in partnership. The Group will also be responsible for overseeing the development and approval of this document on behalf of partner organisations, subject to final sign off by North Yorkshire County Council.
- 2.3 These requirements provide the framework for future work of the Group.

### 3 Local Government North Yorkshire and York (LGNYY)

- 3.1 It is proposed that the Group should play a part in developing the agenda of LGNYY.
- 3.2 Future LGNYY meetings for 2011 will be held on 24 June, 16 September and 9 December. Currently the remaining agreed dates for the Group this year are 14 July and 3 November. The Group may wish to consider whether to realign its meeting dates to fit more closely with those of LGNYY in order to better influence the agenda of these meetings.

### 4 Draft work programme 2011/12

- 4.1 A draft work programme for discussion is attached at appendix 1. It is recognised that this will be subject to change in the future and updates to any agreed programme will be brought to future meetings.

### 5 Recommendations

- 5.1 That the Chief Executives' Group agree a work programme for 2011/12.
- 5.2 That the Chief Executives' Group consider whether to align meeting dates with those of LGNYY.
