

## North Yorkshire Strategic Partnership

### Minutes of meeting on Thursday 12th March 2009 at County Hall, Northallerton

Attendees and apologies for absence are listed at Appendix 1.

#### 1.0 Minutes of the meeting on 11 September 2008

- 1.1 The minutes of the last meeting were agreed as a true and accurate record. There were no matters arising.

#### 2.0 Thematic Partnership updates

- 2.1 Written updates had been provided for information by each Thematic Partnership Chair and were noted by the members.

#### 3.0 Local Area Agreement 2008/11 – Quarter 3 Performance Report

- 3.1 Members noted an information paper updating on progress against the Local Area Agreement 2008/11 (LAA) at the end of Quarter 3. John Marsden updated that the LAA is currently being refreshed and will shortly be reviewed by the Department for Communities and Local Government.

#### 4.0 The Impact of Economic Downturn on North Yorkshire

- 4.1 The focus for the meeting was the theme of economic downturn in North Yorkshire. A number of short presentations were given on a range of relevant issues, with time given for questions and discussion. Key points from both the presentations and ensuing discussions are highlighted below.

#### 4.2 The Economic Downturn: A Central Government Perspective. Rt Hon Rosie Winterton MP

- An Economic Delivery Group (EDG) has been set up at a regional level, comprising key agencies such as Jobcentre Plus, Learning and Skills Council, Yorkshire Forward and NHS North Yorkshire and York, to look at their response to the downturn and consider what strategies can be put in place to tackle it. The EDG ultimately reports back to a national economic council.
- Local Government for Yorkshire and the Humber (LGYH) have developed an initiative to help local businesses during recession, for example in clarifying where they can go for advice.
- Local public procurement plays a critical part in improving the economic situation locally. This includes tourism (for example maximising the Yorkshire Forward funding to promote tourism), farming and the rural economy (local purchasing is important here) and developing and promoting green technologies. However, it was also noted that recent government changes to local procurement processes which were intended to make things easier for SMEs have in some cases had the reverse effect.
- The Minister agreed to investigate whether business tax relief will be extended to assist local businesses. It was also noted that many businesses are unaware of government assistance and incentives available and that further multi-agency work is needed to improve this.

- A lot of people in North Yorkshire are employed by/reliant upon the financial services sector. The Minister has met with the Chief Executive of RBS and is also looking at the impact of the Lloyds TSB/HBOS merger in terms of their presence in the region.

#### 4.3 **The Economic Downturn in North Yorkshire: An Overview**

##### **Jonathan French, York and North Yorkshire Partnership Unit**

- Recent analyses (Job Seeker's Allowance figures etc) for the county and region reveal a mixed picture. A lot of people are finding jobs but there are not as many jobs available as there are people seeking work. The 18-24 age group presents a problem in this regard and will find difficulties joining the local labour market at the end of this school year.
- Similarly, while some sectors are sustaining levels of reduction in employment, such as agriculture and food production. Others such as construction are in serious difficulties.
- Yorkshire Forward has forecast that North Yorkshire is most likely to recover as quickly as possible within the region.

#### 4.4 **The Impact of the Downturn on Businesses and Employment**

##### **Ian Williams: Leeds York and North Yorkshire Chamber of Commerce**

- The national picture reveals that business failure rates are high and business confidence is low. There will be further widespread redundancies. However, again the picture is mixed as although sectors such as financial services are seeing huge job losses, areas within that such as credit management are also stepping up their recruitment.
- Retailers are closing down and it will not be easy for businesses to attract investment. The construction sector is suffering but it is also a problem for the linked support agencies, such as estate agencies.
- On a local level, there is an issue with people wanting to start their own business but finding there is a lack of suitable premises. Rented accommodation is seeing a significant growth in demand, although it was recognised that there is an issue with landlords worrying about paying rates on empty property.

#### 4.5 **The Impact of the Downturn on Tourism**

##### **Clare Morrow, Yorkshire Tourist Board**

- Tourism is now the biggest single sector in Yorkshire. The region is attractive for Europeans and people from within the UK at the moment because of the exchange rate. Another survey also showed that people like to come to Yorkshire and subsequently will come back, although the latest figures do show a drop in business visitors.
- Yorkshire Tourist Board (YTB) have a number of initiatives underway to tackle the downturn. These include:
  - an additional pot of £200,000 which has been spent on a campaign "Get more Yorkshire for your pound";
  - special offers for visitor attractions, advertised through local media and offering added value;
  - international campaigns in Spain, Germany and the Netherlands to bring in more European visitors; and
  - a re-launch of YTB's domestic campaign to be held on 3<sup>rd</sup> April 2009 with over 600 people attending.
- The loss of flights from Leeds Bradford to Heathrow is a concern, as well as the difficulties that small businesses in the sector have in obtaining credit. There is also a low take-up of IT within businesses.

- It was recognised that there is a need to spread visitors throughout the year and not just rely on/retain low-skilled seasonal work in areas such as Scarborough.
- Work is being done to better align the tourism partnerships across the region which will enable better working between cities and elsewhere in North Yorkshire.

#### **4.6 The Personal Impact of the Downturn**

##### **Linda Marsden, Advice North Yorkshire**

- Advice agencies in North Yorkshire saw a 23% increase in client numbers in January 2009. Many people are not aware of and don't know how to access Job Seeker's Allowance and other entitlements such as pension credit when they have not done this before. A lot of people are seeking advice because they fear redundancy.
- Current advice needs centre around short-term working and lay-off and also cases of unfair dismissal and discrimination at work, for example woman losing their jobs when taking maternity leave.
- Nobody really knows how the downturn will pan out and this is adding to the stress already building for those most affected by it.

#### **4.7 The Impact of the Downturn on Housing**

##### **Colin Dales, Richmondshire District Council/North Yorkshire Housing Officers Group**

- In relation to housing, there is no consistent trend developing in North Yorkshire. The market has slowed down in North Yorkshire but the area has been less affected than other sub-regions. Average house prices have dropped by 6.6% in North Yorkshire between 2007 and 2008, compared to a 10.6% reduction across Yorkshire and the Humber.
- The worst affected areas among most property types are Selby, Scarborough and York.
- Increasing number of homeless cases being dealt with by advice agencies.
- Improving performance by local authorities on homelessness prevention is helping at present.
- Ongoing affordable homes target to soak up some housing need.

#### **5.0 Comprehensive Area Assessment – Liaison with Audit Commission Lead Inspector**

5.1 A short paper was presented by John Marsden which proposed arrangements for forthcoming liaison with the Audit Commission's Lead Inspector for the Comprehensive Area Assessment (CAA). The members agreed that:

- The CAA Lead will meet with the NYSP Executive as part of their regular cycle of meetings and if necessary at a special meeting;
- The CAA Lead will meet with the Leaders of the eight North Yorkshire councils, together with the Chairs of the key authorities on the NYSP (e.g. the police Authority and National Park Authorities); and
- The CAA Lead will meet with the Partnership at its September 2009 meeting to share the joint inspectorates' emerging judgements.

#### **6.0 Dates and venues of future meetings**

6.1 The next meeting of the NYSP Partnership will be held on Thursday, 10<sup>th</sup> September 2009 at County Hall, Northallerton. Dates for 2010 meetings were circulated and are as follows:
